

Movement of illegal stays on the total migration, by months




In the first half-year 2006 during controls focused to illegal work foreigners in Slovakia are determined completely 176 cases of illegal employ (working) foreigners. From mentioned number are 17 cases determined during repressive-safety shares "Cudzinci". Most frequently illegal employs (works) was from Korea (40), Vietnam (40), Ukraine (13), Romania (11) a Kuwait (9). In half-year of the year 2005 was nationality illegal employment (working) person to ensue: Vietnam (97), Ukraine (29), Romania (28), Poland (25) and China (20).





Overview of Numbers transport means checked by State Border Section






