One of the most important activities that museums, galleries or premises with the culture value items are obliged to execute is protection and security of collection items that are dealt with legal norms and the premises themselves. They diversify responsibility for the collection items' security among the premises' authority, founder and the premises themselves. The authority is obliged to create personal, material and

technical conditions for securing collections in a museum. Protection and further obligations are imposed by law to a museum. The premises with culture value items are obliged to keep a list/inventory of collection items that are subject to evacuation during the wartime and the state of war, sheltering and safekeeping during an emergency and an emergency situation in peacetime. Their obligation is to secure protection of the culture value items against the effects of the emergencies such as natural disasters, floods, flash floods, fires, against danger of damage, thefts, etc. and to provide for prevention and protection of the culture value items by means of technical devices and systems. The author of the article is focusing on technical solutions of prevention and protection – assessment of the technical devices for protection against the major threat to the culture value items – emergencies caused by fires.
